Notice of Preparation of Amendment and Exhibition of the draft Colac 2050 Growth Plan

Amendment C97 - Colac 2050 Growth Plan

Exhibition period closes Friday 14 December 2018

Colac Otway Shire Council has prepared the draft Colac 2050 Growth Plan, and Amendment C97 to the Colac Otway Planning Scheme. Land affected by the Growth Plan and the Amendment is located in the township of Colac. The draft Colac 2050 Growth Plan will guide the way Colac grows towards 2050, establishing a strategic framework for the future planning and development of Colac.

The Amendment proposes to implement the policy directions identified in the draft Colac 2050 Growth Plan. The Amendment and draft Colac 2050 Growth Plan is supported by the draft Colac Stormwater Development Strategy.

The strategic directions identified in the Colac 2050 Growth Plan are being implemented through Amendment C97, which proposes to:

- Amend Clauses 21.01, 21.02, 21.03, 21.06, and 21.07 of the Municipal Strategic Statement in the Colac Otway Planning Scheme.

Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds or reasons why the Amendment is supported or opposed, and indicating what changes (if any) the submitter wishes to make. To assist Council in their response to submissions, it is useful to explain what parts of the Amendment or Growth Plan the submission relates to, and explain any suggested changes and reasons for these changes.

Name and contact details of submitters are required for Council to consider submissions and to notify such persons of the opportunity to attend Council meetings and any public hearing held to consider submissions.

The closing date for submissions is Friday 14 December 2018. Written submissions should be titled 'Amendment C97 Colac 2050 Growth Plan Submission' and emailed to ing@colacotway.vic.gov.au or mailed to: Strategic Planning, Colac Otway Shire Council, PO Box 283, Colac, Victoria 3250.

The planning authority must make a copy of every submission available at its office for any person to inspect, free of charge, for two months after the Amendment comes into operation or lapses.

The draft Colac Stormwater Development Strategy is a vital part of managing Colac's stormwater network into the future and important to the draft Colac 2050 Growth Plan, a long range planning project that will cater for growth in Colac's population over the coming decades.

A strong understanding of the existing and future flood planning, drainage and stormwater treatment constraints and opportunities is required to facilitate appropriate future development.

The draft Colac Stormwater Development Strategy has been developed to:

- Identify areas in Colac that experience stormwater management challenges which require mitigation to improve the overall drainage system throughout the town; and
- Facilitate the development of land in and close to Colac as part of the planned implementation of the draft Colac 2050 Growth Plan.
