## Planning Permit Amendment

NOTICE OF AN APPLICATION FOR AN AMENDMENT TO A PLANNING PERMIT

**The land affected by the application is located at:** 5600 Great Ocean Road WONGARRA

The application is to amend permit number PP301/2022-1 by replacing the existing building envelope (restriction) on title to include the existing structures such as garden shed, driveway, retaining wall (currently located outside), plus include the development of an outbuilding proposed under PP301/2022-1, amendment to preamble and relevant condition on permit

**The applicant for the amendment to the permit is:** 5600 Great Ocean Road Pty Ltd

**The application reference number is:** PP301/2022-2

**The application is for a permit to:** Building and Works Associated with the Extension and Renovation of Dwelling including Construction of Swimming Pool, Construction of a Shed, Removal of Native Vegetation, and Removal of a Restrictive Covenant (Building Envelope) and Creation of a New Restrictive Covenant (Building Envelope)

You may look at the application and any documents that support the application at the offices of the responsible authority during office hours at Colac Otway Shire Council's customer service centres at 2-6 Rae Street, Colac and 100 Great Ocean Road, Apollo Bay.

This can be done during office hours and is free of charge.

Any person who may be affected by the proposed amendment to the permit may object or make other submissions to the responsible authority.

An objection must be made to the responsible authority in writing, include the reasons for the objection and state how the objector would be affected.

The responsible authority must make a copy of every objection available at its office for any person to inspect during office hours free of charge until the end of the period during which an application may be made for review of a decision on the application.

The responsible authority will not decide on the application before **15 August 2024**.

If you object the responsible authority will tell you its decision.
