#### Bridge work and road closure -Forest Street, Colac

The existing bridge structure on Forest Street will be replaced with new wide concrete bridge structure in order to service current and future vehicle transport needs. The replacement works will include Barwon Water services relocation, installation of new bridge members, bridge approach roadworks and up to current standard safety barrier system.

While works are undertaken, the section of Forest Street from Hearn Street to Colanda Street will be closed for a period of 17 weeks. The road closure will be implemented from 17 October. Detours will be setup for Forest Street traffic to be detoured through Queen Street. Council asks all road users to take care and observe any road signs in place; thank you for your cooperation while these important works are undertaken. ### Pool and spa registration

The registration period for existing swimming pools/spas closes on 1 November, 2020. Colac Otway Shire Council reminds owners of land where a swimming pool/spa is located that it is mandatory to register their pool/spa with Council, as per State Government legislation introduced on 1 December 2019. The new registration and inspection requirements provide for a safer community.

The registration fee to Colac Otway Shire Council for a pool or spa is \$31.84; an additional search fee of \$47.24 may apply where an owner is unable to provide a copy of the building permit or certificate of final inspection for the pool/spa. Failure to register a swimming pool/spa is an offence against the Building Regulations and may attract a fine.

Draft Development Plan - Submissions Invited

Colac Otway Shire Council has recently received a draft Development Plan for the land at 6230 and 6280 Great Ocean Road, Apollo Bay. A previous Development Plan for the land was refused at the Victorian Civil and Administrative Tribunal (VCAT) in 2018.

The current application seeks to address the issues raised in the VCAT decision.

Council invites the community to make submissions on the amended Development Plan prepared for the land, to help inform its decision.

Council recognises the significance of this site being the major entrance to Apollo Bay and is committed to ongoing community engagement and input to the planning process. It should be noted that as there is no statutory process for undertaking public notification on Development Plans, there are also no third party appeal rights (such as appeals to VCAT) for submitters.
