Free Infant **Immunisation Sessions** and Flu Vaccinations

Upcoming infant immunisation sessions in Colac are:

Council is also offering free flu immunisation through the National Immunisation Program for the following members of the community:

- children aged 6 months to less than 5
- Aboriginal and Torres Strait Islander people aged 6 months and over
- pregnant women at any stage of pregnancy
- people aged 65 and over, and
- people aged six months and older with medical conditions putting them at increased risk of severe influenza and its complications.

For those wishing to attend for only flu vaccinations. Council has added an additional half hour to the childhood immunisation sessions. If you require a flu vaccination, please attend one of these sessions:

- Monday 17 June 2pm 2.30pm
