#### 4. WELCOME & ACKNOWLEDGEMENT OF COUNTRY

#### **QUESTIONS RECEIVED IN WRITING PRIOR TO THE MEETING**

#### Mr Nasser Kotb

1. When would the Council consider creating a "Forrest Strategic Plan"?

#### Response from General Manager, Development & Community Services

The Council Plan 2017-2021 identifies the need to undertake a review of the structure plans, master plans and community plans that are already in place for small townships across the Shire.

Officers are currently in the process of developing a program of reviewing the appropriateness of the existing township plans and strategies. Information from this process will be used to develop a four year program to develop or review township plans across the Shire, including for the Township of Forrest.

2. What is the strategy of the Council to reach an agreement with the Traditional Owners? How much of the strategy has been executed in percentage? When would the Council envisage the Agreement to be signed (Date please)?

#### Response from General Manager, Development & Community Services

The Eastern Maar Aboriginal Corporation is the representative body for Traditional Owners of Country that includes what is now known as the Otway Ranges.

Council has previously held discussions with Traditional Owners regarding the potential to develop an agreement between Traditional Owners and Council. Council was advised Eastern Maar Aboriginal Corporation were awaiting formal notification from the State Attorney General's office regarding the Threshold Statement relative to the Traditional Owner Settlement Act and once this process was resolved discussion regarding an agreement could be further considered. This is likely to be in 2018.

Meanwhile Council has been engaging the local aboriginal community in the development of an Aboriginal Gathering Place in Colac and is establishing a stronger relationship with the local Aboriginal community.

The new Municipal Health and Wellbeing Plan has several actions to acknowledge and celebrate our Aboriginal community's culture, history and aspirations.

#### **Noor Petersen**

1. What is the Council position regarding support for Victoria joining other states banning the single use plastic bag? What other initiatives does the Council follow/promote re sustainability and being more environmentally friendly?

#### Response from General Manager, Development & Community Services

While Council has not formally declared support for Victoria joining other states banning the single use plastic bag, Colac Otway Shire Council and its Environment and Waste Management units support community action towards plastic bag free status.

Council recently supported Apollo Bay's Boomerang Bag initiative by providing \$2500 funding (Environment and Waste Management Units) to purchase materials to assist with the start-up of the program which was formally launched in July 2016 and provides free reusable bags that can be returned at outlets throughout Apollo Bay.

The Colac Otway Sustainability group recently approached Council for advice and assistance with their proposed plastic bag free campaign for Colac and Council offered its support to assist and promote the program as it evolves.

Council also offers and can supply a Waste Wise trailer for event organisers. The trailer contains waste and recycling bins to ensure that waste from events is responsibly disposed of.

Council's Events team has also commenced work on the introduction of an Environmentally Sustainable Events Policy that will cover purchasing and packaging (plastic bags, plastic drink bottles, straws, balloons, etc.), waste and recycling collection systems and clean-up practices and applies to all events conducted on land, in buildings or roads managed by Council.

Council has a longstanding history of taking action to improve the environmental sustainability of its services and operations. Targets set in Council's Environment Strategy 2010-2018, Sustainability Policy 2013 and specifically Council's carbon neutral target by 2020 directly support energy efficiency, water conservation, resource use reduction and recycling and the deployment of localised renewable power generation on the roof space of its buildings. Council already has one large solar power generation system at Rae St/COPACC and four small solar power generation systems on other facilities such as the Apollo Bay VIC. Other major sustainability initiatives planned for this financial year include two more large solar projects and the upgrade of public open space lighting with more efficient globes that will further reduce Council's carbon emission and make substantial financial savings in the future.

#### Mandy Bishop, Forrest & District Community Group

 Strategic planning: The Forrest Township Masterplan and Community Infrastructure Plans have reached the end of their timespans and need to be revisited to meet the demands on the town that have emerged over recent years and those into the future. Each of these plans, along with the MTB Strategic Plan, were developed at significant cost in terms of consultant fees and, unfortunately, little often remains to put the plans into action.

The Forrest community has a diverse skills base, including a variety of highly qualified and talented professionals and tradespeople. In addition, there is a culture of volunteering which was recorded

at the last census at twice the national average and a history of managing assets and coordinating community input into significant projects (eg the recent transfer of DWELP properties to community management).

Forrest townspeople have proven their capacity to consult, collaborate, plan and manage implementation of projects. Would the council considering endorsing a community-led process for developing a Forrest Master Plan, and allocate the funding that would otherwise be paid to consultants to develop the Master Plan towards co-funding (with community in-kind contributions and other potential grant providers) the implementation of priority interventions?

#### Response from General Manager, Development & Community Services

The current Forrest Structure Plan which was prepared in 2011 is still relevant to the issues, opportunities and challenges of the Township. However, Officers are currently in the process of developing a program of reviewing the existing township plans and strategies. Information from this process will be used to develop a four year program to develop or review township plans across the Shire, including for the Township of Forrest.

During the review of the current Plan, Council will consult with the community and other stakeholders. Forrest community will be able to provide input into the development of the revised Plan for the Township of Forrest.

- 2. Community priorities: A recent initiative of the Forrest and District Community Group involved consulting with the community to create a 'Top 10' priority list for the town. Several of these have been, or are being, addressed. Could the council please provide an update on the opportunity to address the following priorities:
  - a) Implementation of the Forrest Mountain Bike Strategy tourism is the economic future for Forrest and the trails are critical to our future success.

#### Response from General Manager, Development & Community Services

The Forrest Mountain Bike Strategy has been endorsed by Council. Recently an application for funding to support the progress of the Strategy, through a State Government Sport & Recreation Grant was unsuccessful. Negotiations have been held with VicRoads to secure funding for an upgrade of the unsafe crossing of Colac — Forrest Road linking Tiger Rail Trail and Boundary Road to Yauger Trail Head. These discussions have been positive. A meeting was also held on 9 August, with a representative from the Forrest Mountain Bike Club, to also investigate future options.

b) Sealing the service road - the businesses along the service road are growing in number and success. This creates a need for parking and to manage the dust that the volume of traffic generates.

#### Response from General Manager, Infrastructure & Leisure Services

I thank you for the suggestion. We will ensure that this possible project is scoped, the cost estimated and that it is submitted to Councillors as a candidate project for the 18/19 Capital Works Program. This process will involve measuring the costs and benefits of the project and comparing it to other possible projects across the Shire so that Council can decide on whether it should be included in the program.

#### Emma Pakula

I am thrilled to live in a region that identifies as a Refugee Welcome Zone. Can you please explain what the Council is doing to live this commitment, and what we can be doing as residents to support this principle?

#### Response from General Manager, Development & Community Services

The Colac Otway Shire Council agreed to become a 'Refugee Welcome Zone' at its Council meeting of 26 June 2014. This was followed by the signing of the declaration at an event held on 10 September 2014 attended by members of our Iranian, South Sudanese and Afghanistan refugees, local service providers, support groups and the Refugee Council of Australia. The ceremony celebrated the contribution made to our community by our refugees and included a sample of their craftwork and a photographic display.

Signs have also been installed at the eastern and western boundaries of this Shire indicating that the Colac Otway Shire is a Refugee Welcome Zone.

Council reaffirmed its commitment to welcome asylum seekers, uphold their human rights, demonstrate compassion and enhance cultural and religious diversity in the community. To this end, Council will:

- Promote social inclusion, equity and community participation in Colac Otway Shire
- Actively work towards providing opportunities for asylum seeker communities to participate in community life
- Raise awareness and knowledge about asylum seekers within the wider community
- Celebrate the community contributions of asylum seekers, who bring skills, expertise, motivation, and resilience
- Collaborate with our partners, community groups and local agencies to strengthen operations or capacity and enhance local coordination
- Advocate for appropriate resources to meet the needs of asylum seekers.

#### **Graham Costin**

To raise community awareness and promote waste reduction, will Council report the quantities of waste collected in the Otway Coast region (disaggregated by category), the final destination of each waste category, and the costs of transfer and disposal for each category in dollars and GHG emissions?

#### Response from General Manager, Corporate Services

Colac Otway Shire disposed of approximately 5220 tonnes of garbage to the Naroghid landfill site. The cost of this disposal was approximately \$734,000; the haulage costs were approximately \$196,200.

Colac Otway Shire disposed of approximately 2430 tonnes of organic material to Camperdown Compost for processing (as published in the spring edition of the Community Matters magazine). The cost of this disposal was approximately \$50,000; the haulage costs were approximately \$62,000.

Colac Otway Shire disposed of approximately 2,200 tonnes of recycling. (This information is to be published in the summer edition of Community Matters magazine.) The haulage costs were approximately \$123,000.

Colac Otway Shire receives a rebate for recycling material of \$26.30 per tonne. The Shire's recycling material is sent to SKM Recycling in Geelong for processing.

In 2016-17, the Colac Otway region recycled the following (in tonnes):

#### QUESTIONS RECEIVED VERBALLY AT THE MEETING

#### Yvonne Francis, Apollo Bay

The subject of my question is planning application number PP169/2017-1 on 275 Barham River Road. This subject is not on today's agenda. A short preamble: the Great Ocean Green proposal caused a huge upheaval right across Australia and any repeat performance like that would have a detrimental impact on business. My question has two parts: the impact of this proposal on the Barham River Road to impact on people, and threatened species.

 Were the residents of Apollo Bay and owners of businesses, like myself, properly and thoroughly consulted? It is significant because of the sheer size and extent of the proposal. It includes 322 villas, shops, a pool and accommodation.

#### Response from General Manager, Development and Community Services

It has actually just been exhibited for community feedback at the moment through the planning process. No decision has been made at all, so we certainly encourage you to jump onto the Council's website, or I can meet you afterwards as well and we can give you access to some of the documentation for that, so you can have a good look through the application. We would love to get your feedback on the application.

2. Threatened species is the second part of the question. Were any federal agencies consulted in regards to exploring possible impact on threatened species, such as the migratory protected swamp birds, including the Japanese Snipe, and what is the response under the Commonwealth Environment Protection and Biodiversity Conversation Act?

#### Response from General Manager, Development and Community Services

No, the Federal Government hasn't been consulted on the application. The referral authority under these circumstances is actually the State Government, DELWP - the Department of Environment, Land, Water and Planning. They have automatically been referred the application. One of the things that you will find online or at the Customer Service Centre in Apollo Bay is a flora and fauna assessment done by the developers and that will obviously look at and consider the issues in and around the impact on flora and fauna. I encourage you to have a look at that document as well.

That is Victorian law. My question is about Commonwealth.

#### Response from General Manager, Development and Community Services

My response is that it hasn't been referred to Federal Government. We are not aware through the flora and fauna assessment it actually triggers that requirement to be done.

No threatened species under the EPBC Act?

Response from General Manager, Development and Community Services

We are not aware of any impact on threatened species.

Ian Seuren left the meeting at 4.23pm; returned at 4.25pm.

#### Nasser Kotb, Forrest

What is the Shire doing about carbon capture in the shire?

#### Response from General Manager, Development and Community Services

There are several revegetation programs Council is looking at where it is looking at carbon capture opportunities, but also referring to some carbon emission reduction. We have been doing some significant work as referred to in the questions before, particularly around solar work. There have been some fantastic results there.

#### Response from the Chief Executive Officer

In terms of some of the initiatives that are being undertaken and in terms of  $CO_2$  equivalent savings, earlier statistics read out indicate 1357.13 tonnes. Those figures will be in the minutes of this meeting and we will be able to see the recycling initiatives that the Council has undertaken that in fact lead to a reduction of carbon.

#### 6. TABLING OF RESPONSES TO QUESTIONS TAKEN ON NOTICE AT PREVIOUS MEETINGS

#### Alan Billing, Larpent

What action will Council take to correct the misinformation that Council has circulated throughout the community [in regards to rate notices]?

#### Response:

I agree with the CEO that we are aware of no such error with any individual rates notice, the comments made in the budget regarding the drop in general rates is factually correct in that each assessment in the farm category has dropped general rates between 1.3% to 1.40% depending on the value of the property, combining assessments as Mr Billing has noted would not affect this. If Mr Billing has a specific issue with a particular assessment, we would welcome him contacting our rates department to discuss any errors.

#### Peter Jacobs, Separation Creek

Could the CEO please outline the reasons why the Social and Sporting Club cannot receive a permit for Harrington Park for any activities within?

#### Response:

The Social and Sporting Club could receive a permit for an appropriate event in an appropriate location. The applications submitted in the past have not been appropriate events to be held in Harrington Park. The reasons for this have been previously provided and include the following:

• The site is considered to be unsuitable due the close proximity of houses and the potential noise issues, as evidenced following the event in 2015.

- There are no toilet facilities on site, and the closest facilities are across a road which is not ideal.
- Local licensing inspectors have expressed strong reservations regarding matters such as security and traffic management. These concerns are also held by VicPol and the CFA.
- If a liquor licence was issued there would be a requirement for an immovable fence around the park, which poses evacuation issues.

#### Simon Arundell, Bungador

[Regarding the defined benefits superannuation scheme] why has the Council got that obligation when State and Federal Governments, which clearly have more power than you - you're just a minnow - force this on, getting on the good side of the public servants back in those days? We have to throw the baby water back, don't we?

#### Response:

There have been no new members to the defined benefits fund since 31 December 1993. Due to the pre-existing contractual commitments to these employees, Council will continue to have a commitment to these members until death. This is a contractual arrangement that was entered into back before this date and can't be avoided; any similar contractual arrangement at the state or federal level would also still be in force.

#### Sherryl Smith, Wye River

[With regards to bushfire recovery and a review of services] will you undertake to speak to those directly impacted?

#### Response:

As noted at the Ordinary Council meeting, Emergency Management Victoria has led the review of the response to the Wye River and Separation Creek fire which included engaging the affected community. The findings from this review are being considered by Council to determine where Council could improve its services and systems. No further community consultation is proposed.
