1 DECLARATION OF OPENING OF MEETING

"Good afternoon. I formally declare this meeting open.

My name is Anne Howard and I am the Chief Executive Officer of the Colac Otway Shire.

I would like to start this afternoon by acknowledging the traditional custodians and law makers of this land, their elders past and present and welcome any descendants here today.

Today Council will determine the terms for and elect the Mayor and Deputy Mayor for the Council in accordance with Sections 25-27 of the Local Government Act 2020. Section 25(3)(a) of the Local Government Act 2020 requires that the election of the Mayor be conducted by me. Once the election of the Mayor has occurred, I will vacate the Chair and the elected Mayor will assume the role of Chair for the remainder of the meeting.

I would like to advise that all Council meetings are recorded and live streamed, with the exception of confidential matters. This includes the public participation sections of meetings. The live stream recording of this afternoon's meeting will be available on the website as soon as practicable."

public question time for this particular meeting will be restricted to questions relevant to the purpose of the meeting which is to elect a mayor and potentially a deputy mayor. Any other questions will be deferred to the Council meeting scheduled for 22 November 2023.

QUESTIONS RECEIVED IN WRITING PRIOR TO THE MEETING

Has the Colac Otway Shire Council thrown out the State Government order that a Deputy Maor is to be reimbursed half a Mayor's allowance so it can claim if a Deputy Mayor is elected no financial implications arise from accepting the recommendation for the election for 2023-2024 contained in the agenda for the meeting on 8th November 2023?

Do not forget that office was discontinued after State Government changed the rules on payment of a Deputy Mayor. For every \$10,000.00 above a Councillors' allowance a Deputy Mayor is paid, this will inflate the remuneration by over \$11,000.00 per annum due to superannuation being paid on the excess then other expenses also to be added.

We must wonder what other urgent works will be overlooked to try and balance the books.

Response from the Chief Executive Officer

While Council resolved not to establish the office of Deputy Mayor at its meeting held on 9 November 2022, this decision does not preclude Council from reconsidering the matter at any time.

The base allowances payable to the Colac Otway Shire Mayor, Deputy Mayor and Councillors from 1 July 2023 is:

Mayor \$102,650Deputy Mayor \$51,325Councillors \$31,980

The allowances are set by the Victorian Independent Remuneration Tribunal and are inclusive of superannuation entitlements.

Provision is made in Council's annual budget for the Deputy Mayoral allowance.
