What is Council's explanation for the tens of millions of variation between the balances at the end of June 2017 when balances moved in opposite directions to each other? The increase in surplus is shown as a deficit of over ten million dollars and the appropriations positive over ten million. There is a massive difference of over 24 million for the year.

Response from Manager, Financial Services

Apologies Mr Judd, can you tell where you are looking at those particular figures?

The figures are in the agenda. It shows over 11 million deficit for the year, although you claim it is a surplus. It is in brackets which according to the details, it is a deficit.

Response from Manager, Financial Services

Thank you, I understand the question now. The reason why that is showing as a bracket is because in accounting terms a bracket denotes a credit, which means income. So a bracket in accounting terms means an increase in income, or a decrease in expenses. Apologies if that caused some confusion, Mr Judd.
