BUILDING PERMITS – (Private Building Surveyors issue building permits in the Colac Otway Shire)

- * Indicates Statutory fee set by Victorian Building Authority VBA under the Building Regulations 2018.
Statutory fees **DO NOT** incur GST.
- **Building Application Fee:** Based on cost of works. (Cost of works must include material & labour at a **commercial cost** and **NOT** owner builder cost) and if applicable:
- **Lodgement Fee:** To cover storage of the building permit for life of the building (excludes community residential buildings, e.g. disability homes, aged care, prisons, etc.);
- **Building Levy (for works over \$10,000):** Funds the building control system in Victoria.
As of 1st July 2019 Building Levy is paid directly to Victoria Building Authority (VBA).

Report & Consent:	Report & Consent – Siting variation, this fee is charged per regulation you're requesting to vary Adjoining Owners Comments – Fee for Council to undertake request for adjoining owner's comments on your behalf Demolition Consent - for complete or partial demolition of a building
Copies of Building Permits or Plans:	Search fee for obtaining copy of building permit or plans. This is a non-refundable fee and while every effort is made there is no guarantee documents can be located.
Place of Public Entertainment/ Temporary Siting:	PoPE - Permit to ensure event complies with building legislation Temporary Structure – Permit to ensure Marquee, tent, stage, etc. complies with building legislation
Building Audits:	Essential Safety Measures – Inspection of ESM requirements in commercial or public buildings
Property Information Certificate:	Fee for property information for sale of property (i.e. building permits issued in last 10 years) or building on the property (i.e. bushfire prone, flood prone).

- The Building Permit fee covers application assessment, issuance of Building Permit, up to 4 inspections, and issuance of Final Certificate/Occupancy Permit
